RE: RECAP OF THE LACSD-AWAC TOWN HALL HOSTED BY SENATOR OCHOA BOGH.

Dear Woods Property Owner:

On June 10th, Senator Ochoa Bogh hosted her town hall meeting concerning the LACSD AWAC takeover at Rim High School and the community came out in full force. Once again, the community was completely against LACSD taking over AWAC. The Senator was informed that this bill would only benefit LACSD and that it was about *Money, Power* and the *Water Rights to all of the Woods*. The big takeaway from this meeting was that the Senator is now considering rescinding SB1405 based on the sincere input she got from the community. She asked that AWAC send her a letter requesting the rescission.
